
## Notes on the function gsw\_beta(SA,CT,p) (which is identical to gsw\_beta\_CT(SA,CT,p))

This function, **gsw\_beta**(SA,CT,p) evaluates the saline contraction coefficient with respect to Absolute Salinity at constant Conservative Temperature from the 48-term rational function expression for density of **gsw\_rho**(SA,CT,p) (which is identical to **gsw\_rho\_CT**(SA,CT,p)). This 48-term rational function expression for density is discussed in McDougall *et al.* (2011) and in appendix A.30 and appendix K of the TEOS-10 Manual (IOC *et al.* (2010)). The saline contraction coefficient  $\beta^{\Theta}$  is defined as


$$\beta^{\Theta} = \frac{1}{\rho} \frac{\partial \rho}{\partial S_{A}} \Big|_{\Theta, \rho}, \qquad (1)$$

and when evaluated from the 48-term computationally-efficient expression for density, the rms error compared with the same saline contraction coefficient evaluated directly from the TEOS-10 Gibbs function is  $0.1 \times 10^{-6}$  kg g<sup>-1</sup> in the "oceanographic funnel" (see Figures 1 and 2 below). Compared with the mean value of  $\beta^{\Theta}$ , this error is small compared with the ratio of the uncertainty in the thermal expansion coefficient to its mean value, and so the error in  $\beta^{\Theta}$  is negligible. Hence we may take the saline contraction coefficient  $\beta^{\Theta}$  evaluated form **gsw\_beta**(SA,CT,p) as essentially reflecting the full accuracy of TEOS-10. Exact values of  $\beta^{\Theta}$  may be evaluated using **gsw\_beta\_CT\_exact**(SA,CT,p).

Further comments on the 48-term rational function expression for density may be found in the Help file of **gsw\_rho**(SA,CT,p).
